Late Enrollment

✓ After April 1st enrollment can still be done through 4-Honline, **HOWEVER** the member will **NOT** be officially approved until the \$25 late fee and \$10 activity fee is paid to the Extension Office.

Activity Fee

- ✓ Remains \$10 per member
- ✓ Due April 12
- ✓\$25 late fee enrollment after April 1 May 1

 - Allows Angie to file club 990e with IRS






Club By-Laws

What's New for Livestock

All Livestock Fact Sheets:

- ✓ Animals brought to fair Sunday, August 4th, 5-9 pm Animals released from fair – Sunday, August 11th, 9 am till 1 pm (exception for Swine being sent to packers)
- ✓ Grooming/fitting of animals at the Erie County Fair should primarily be done by the Junior fair exhibitor, with limited help from other Erie County Junior Fair exhibitors, immediate family, and/or that exhibitor's 4-H club advisor or that exhibitor's FFA advisor. (deletion of 'livestock species committee members').



What's New for Livestock All Livestock Fact Sheets:

- Following the possession deadline established by the Erie County Junior Fair, an animal may only be exhibited by the project member in any junior livestock exhibition, including at the Ohio State Fair. In shows outside junior livestock shows/exhibitions, following the county possession deadline, a project animal may only be shown by the youth exhibitor or family members. If shown by a youth outside of the immediate family, this constitutes a change in ownership, and that animal would be ineligible for exhibit at the Erie County Fair. See Ohio Department of Agriculture's Livestock Exhibition Rules for additional details.
- Leasing market animals for youth exhibition projects is not permitted under any circumstances. Exhibitors who are leasing breeding animals or dairy animals must submit a lease agreement to the Erie County Extension Office by May 11th.

Quality Assurance

THE 45-DAY RULE

Quality Assurance MUST BE completed after October 1, 2023 and before June 21, 2024 to compete in the Erie County Fair. If a member is planning to participate in the Ohio State Fair, they must complete QA by June 1, 2024.

TESTING OUT OF QUALITY ASSURANCE

Youth who are at least 15 as of January 1, 2024 are able to test out of Quality Assurance for the remainder of their 4-H career. Test out sessions will be offered 1-hour before each of the in-person QA sessions and by appointment.

ERIE COUNTY QA COMPLETION OPTIONS:

YQCA Training Online

Youth may complete the online YQCA course at https://yqcaprogram.org/ This is the only approved online course. Youth must complete the correct course for their 4-H age. The entire course must be completed before June 21, 2024 to be eligible to compete. Cost is \$12.
